# CONCLUDED CONTRACT FOR ECOCEMENT PLANT CONSTRUCTION AND FOR PLANT OPERATION / MAINTENANCE ETC. AT TAMA AREA, JAPAN

On July 31, 2003, TAIHEIYO-EBARA Consortium, formed by Taiheiyo Cement Corporation, Tokyo (TAIHEIYO) and Ebara Corporation, Tokyo (EBARA) have successfully concluded a contract with Tokyo Santama Area Regional Association of Waste Disposal, for the constructing of a new Ecocement plant at Tama area, at a contract value of 27.18 billion yen, and also concluded a long term contract for the said Ecocement plant operation & maintenance and marketing the Ecocement product for 20 years, at a contract value of 53 billion yen.

This is a biggest public works to be carried out by TAIHEIYO towards Ecocement plant business. The TAIHEIYO-EBARA Consortium has formed a new company - Tokyo Tama Ecocement Inc., for handling Ecocement plant business.

Towards waste recycling business, the existing cement plants of TAIHEIYO group, so far receive waste materials and by-products generated by other industries as well as from local municipalities and utilize them as an alternative raw materials or fuels. Also TAIHEIYO is receiving cost for the treatment of above-mentioned waste materials etc.

However, this time, TAIHEIYO has entered into plant construction, operation& maintenance activities, that is, plant engineering business. TAIHEIYO shall construct its first business model, thus entering into a new business area. Ecocement technology, as a resource recovery technology, has not only attracted the attention of local Municipal Corporations in Japan but also overseas organizations.

TAIHEIYO's achievement in Ecocement technology is expected to boost the future Ecocement business opportunities.
